Qualifying students (those eligible to apply for financial aid and accept offered Pell Grants) do not pay any tuition (approximately \$12,000 per year).

Tuition costs are covered by a combination of Pell Grant, Federal Work College funds (BGU is a Federal Work College) and an institutional scholarship covering any remaining tuition balance.

Students taking this program are training to be full-time missionaries or intercultural religious works and therefore, their projected earnings are not reflected in the wage scales created by the U.S. Government.

BGU became Title IV eligible in January of 2015.
